A DPO will have to possess expert knowledge of data protection law and practices. Under the GDPR, you must appoint a DPO if:

- You are a public authority or body;
- Main activities of your company require large scale, regular and systematic monitoring of individuals (for example, online behaviour tracking); or
- Main activities of your company consist of large scale processing of special categories of data (for example, health data) or data relating to criminal convictions and offences.
- You can appoint a DPO if you wish, even if you are not required to under the GDPR and it is strongly recommended to do so as appointing a DPO demonstrates to customers that your organization is serious about protecting personal data and it assists you with all issues con-cerning data privacy with expert knowledge.



Debt Collection


Employment


Insurance & Personal Injury


